

The Society currently has 10 Board members, 4 staff members, and 130+ volunteers that support the Society through, client, event, administration and work shifts at our community thrift store Nu<sub>2</sub>U.

## Message from our Board Chair



Earlier this year in April the Board hosted a strategic planning event over two evenings to set our one-year goals and to plan for the next five years. Last year I spoke about focusing on our future and that is what an effective Board should be doing on a monthly basis. We have grown and changed over the past twelve years, thanks to the good foundation laid by our founding members. Our Bereavement Support team offers support to those experiencing the death of a loved one and seeking help through their journey. The Society offers one on one (bereavement bridging) support as well as eight-week bereavement groups that are available spring and fall.

Our Nav-CARE 's specially-trained volunteers help improve the lives of people living with chronic/terminal illness who are not in need of hospice palliative care. Our volunteer navigators help these clients create connections to community services and resources, and provide them with caring compassionate emotional and social support. As a benefit to providing NavCARE the clients transition to end of life support is gentle and they feel supported.

Our Nu2U thrift store has added a revenue stream to our Society but it also provides support to the community through donations of products to those in desperate need. As we grow and focus on our future, these are a few of the areas we feel we need to communicate to our communities. We are much more than what our vision statement implies.

After swift consideration, the Town and the Society reached an agreement to keep the store open under the Society's leadership. The Nu2U Community Thrift Store not only serves as a sustainable revenue source for the Society but also offers valuable community support by providing affordable household items, mentoring, and supplying essential items to families in need at no cost.

# Olds United Church Collaboration February, 2023

In February 2023, the Olds & District Hospice Society relocated to the Olds United Church. This move greatly enhances accessibility for our clients. It also aligns with our vision for community support, as we share common goals. Our new shared space enables us to conduct group bereavement sessions, provide one-on-one bereavement support, and host our day hospice program in the hall area. Furthermore, our Board and Committees have a dedicated space for meetings and gatherings in the fellowship hall.



## What Matters Most

#### **Hospice Support**

The Society offers hospice support whether you are journeying at home, hospital or in our two community hospice suites. The Hospice Suites offer a cozy environment for our clients and families in need. Hospice support includes our palliative trained volunteers if needed. All support is offered at no charge to the individual or family.



#### **NavCARE Support**

Nav-CARE 's specially trained volunteer navigators help improve the lives of people living with chronic/terminal illness by creating connections to community services and resources and providing caring, compassionate emotional and social support.



#### A Way Forward, Day Hospice Program

The Day Hospice Program provides support to adults with a progressive life-threatening illness by offering opportunities to participate with others in activities that meet the physical, emotional, social and spiritual needs of the participants. The Day Hospice Committee (Committee) will oversee the planning and delivery of the Day Hospice 'A Way Forward' Program.



#### **Bridging with Bereavement and Group Support**

The Society offers one on one (bereavment bridging) support as well as eight week bereavement groups that are available Spring and fall. Our bridging program offers four sessions at no cost for our clients and then they have the opportunity to continue with our bereavement facilitators in their private practice or participate in a group session at no cost.

#### Death Cafe - March 17, 2023

On March 17, 2023, the Olds & District Hospice Society hosted its first-ever "Wills & Estates" Presentation by Dan McPherson of Elevator Law. This informative session was offered free of charge and attracted twenty-nine participants from Olds and the surrounding area. Attendees had the opportunity to learn about important financial and legal aspects related to end-of-life planning, while also enjoying a delicious lunch.
